

# ASX RELEASE | Schrole Group Limited (ASX: SCL)

## **Resignation of Non-Executive Director**

18 May 2021: Schrole Group (ASX: SCL) ("Schrole" or the "Company"), advises of the resignation of Non-Executive Director, Mr Shaun Hardcastle, effective 18 May 2021.

Mr Hardcastle has been a Non-Executive Director of Schrole since the Company's listing on the Australian Securities Exchange in 2017. Since then, Mr Hardcastle has played a key role in the Company's growth.

Mr Hardcastle's key contributions include:

- Assisting Schrole through the listing process.
- Negotiation of Schrole's partnership with Faria Education Ltd (see ASX release, "Strategic investment via convertible note and share placement for binding commitments of \$5m", dated 13 May 2020).
- Ongoing legal and governance advice as the Company grew from \$1.4 million at the time of the listing to \$6 million revenue in 2020.

Chairman Stuart Carmichael said, "On behalf of the Board, I would like to thank Shaun for his significant contribution to the Company over the last four years during his tenure as a Non-executive Director. Shaun remains highly supportive of Schrole and we expect that he will continue to support the Company in a legal capacity in the future."

**Schrole Engage** is due for first release in 2H2021, and will provide contract management and onboarding software for schools.

**Schrole Cover** is a cloud-based software platform that engages relief staff at the touch of a button.

**Schrole Develop** provides accredited professional development solutions contextualised to client needs.

**Schrole Events** is due for first release in 2H2021, and will provide regionalised online recruitment events including candidate to school SmartMatching and video interviews.
