Wiluna Mining Corporation Limited (“Wiluna Mining” or “Company”) advises of the issue of a total of 19,703,876 ordinary fully paid shares (Shares) at \$1.00 per share, pursuant to the non-renounceable pro-rata entitlement issue (“Offer”), which closed on 17 May 2021.

A total of 18,411,826 Shares were issued pursuant to application for entitlements under the Offer and 1,292,050 Shares were issued pursuant to applications for the Offer shortfall (refer ASX announcement 20 May 2021 for further details). The balance of 11,850,000 shortfall shares will be issued in due course pursuant to the terms of the Offer.

The Company also advises of the issue of 20,700 Shares to employees on the exercise of unlisted options expiring 31 December 2021.
