- **Hammer completes Share Purchase Plan raising the targeted \$1.0M**

Hammer Metals Ltd (ASX:HMX) (“Hammer” or the “Company”) is pleased to advise that it has successfully completed its Share Purchase Plan (“SPP”) announced 23 April 2021.

The SPP was offered at the same issue price as the \$5.0M Placement announced 23 April 2021 (\$0.095) and was well received by eligible shareholders. Hammer closed the SPP earlier than intended on Wednesday 19 May 2021 at 5pm (EST) with bids well in excess of the targeted \$1.0M.

Hammer has scaled back bids in accordance with the terms of the SPP, accordingly 10,526,254 shares have been issued on Tuesday, 25 May 2021 raising \$1.0M. The Company will process refunds in a timely manner.

The Company is now well funded to proceed with its planned accelerated exploration efforts including an:

- Aggressive exploration program in Mount Isa; and
- Target generation and drilling at the Bronzewing South and North Orelia projects at the Company’s 100% owned Yandal Gold Project in Western Australia.

The Directors would like to thank participating shareholders for their ongoing support.
