APPENDIX 2A – ENTITLEMENT OFFER SHORTFALL

Wiluna Mining Corporation Limited (“Wiluna Mining” or “Company”) advises of the issue of a total of 2,240,000 ordinary fully paid shares (“Shares”) at \$1.00 per share, being shortfall shares pursuant to the non-renounceable pro-rata entitlement issue (“Offer”), which closed on 17 May 2021 (refer ASX announcement 20 May 2021 for further details).

Wiluna Mining anticipates the issue of the remaining 9,610,000 shortfall shares to occur in the coming days.

The Company also advises of the issue of 488,400 shares at \$1.00 per share in lieu of cash payment for commission and services provided in respect of the \$39 million equity capital raising announced to ASX on 24 March 2021 (“Consideration Shares”). The Consideration Shares were issued without shareholder approval pursuant to the Company’s placement capacity under ASX Listing Rule 7.1.
