Entitlement Issue Participation Instructions

Dear Shareholder,

Guidance on how to participate in the Entitlement Issue is set out below. The simplest manner is to access your personalised Entitlement and Acceptance Form where you register your Acceptance and then process payment through BPay and your bank.

You can access the form even if you have not received an email or the instruction form has not arrived in the mail.

1. Offer Website

Shareholders can access their personalised Entitlement and Acceptance form directly on the internet. You will be required to enter your unique 10 digit HIN or SRN number which is located on the forms which state your shareholding. These numbers begin with either and X or an I, usually with two zeros and then a unique 8 digit number;

EXAMPLE - HIN = X0012345678 or SRN = 10012345678

One of these numbers are generally located in the information box on the Chess Holding Statement you should have received from the ASX or from your broker or on-line if you use an internet trading platform.

The number of Shares to which you are entitled (your Entitlement) is shown on your personalised Entitlement and Acceptance Form which, along with the Prospectus, and is accessible at the link above.

The website provides instructions on how to retrieve the BPay details and accept your entitlement.

Amount that you can Accept

While the Offer is for 1 new share for 10 shares held, shareholders can apply for less or more shares than the allocation. In order to do this, the amount of money paid by yourself into the BPay account (from your internet bank site), using the Payment Reference Number, actually determines the number of shares that will be allocated. By multiplying the number of shares you wish to putchase by 0.2 and paying that amount into the Bpay, the transaction is completed.

The BPay reference number is unique to your HIN/SRN and the system identifies you as the applicant.

2. Investor Centre

Eligible Shareholders may also access and securely download their personalised Application Forms from Computershare's Investor Centre website.

If the holder already has a portfolio set up the form can be retrieved through their portfolio.

If the holder does not already have an Investor Centre portfolio they can download the form by clicking on 'Access a Single Holding'.

Instructions to download the form as follows:

- 1. Go to https://www-au.computershare.com/Investor/ and select 'Access a Single Holding';
- 2. Confirm your shareholding details: residency status; Securityholder Reference Number (SRN) or Holder Identification Number (HIN); your registered postcode or country if overseas; enter the company name in the field "Select the company you hold shares in from the drop down";
- 3. Terms and Conditions Enter code and click 'Agree and Continue', once you agree;
- 4. Select 'Statements & Documents';
- 5. In the list of statements and documents, select the 'View PDF' button next to 'Entitlement Acceptances';
- 6. Select 'Open', then save and print as required.
