# NOSIB, MORE EXCEPTIONAL COPPER, LEAD, VANADIUM & SILVER INTERSECTIONS Up to 9m @ 3.66 % Copper, 11.91% Lead, 3.62% Vanadium ( $V_2O_5$ ), 7.70q/t Silver

 Results from remaining 7 of 15 RC drillholes at Nosib have continued to produce exceptionally high-value copper-lead-vanadium-silver intersections from shallow depth, including:

- NSBRC010: 29m @ 1.54% Cu, 4.49% Pb, 1.19% V<sub>2</sub>O<sub>5</sub>, 6.97g/t Ag from 2m

incl. 13m @ 2.83% Cu, 9.18% Pb, 2.52% V<sub>2</sub>O<sub>5</sub>, 6.57g/t Ag from 3m

incl. 9m @ 3.66% Cu, 11.91% Pb, 3.62% V<sub>2</sub>O<sub>5</sub>, 7.70g/t Ag from 3m

- Near surface copper, lead and vanadium intersections are open along strike to the northeast and southwest, representing a significant open-pit target
- Deeper copper silver intersections extend well beyond the previous development and indicate potential for Khusib Springs style high-grade copper-silver mineralisation at depth
- Further drilling is planned to both extend the shallow copper-lead-vanadium deposit and test for deeper, high-grade, copper – silver mineralisation
- Khusib Springs copper silver prospect drilling results expected to be finalised shortly
- Company has approximately \$3 million in cash to fund future drilling programmes

Golden Deeps Limited ("Golden Deeps" or "Company") announces further exceptional copper (Cu), lead (Pb), vanadium ( $V_2O_5$ ) and silver (Ag) intersections from the final 7 of 15 reverse circulation (RC) drillholes recently completed at the Nosib Block ("Nosib") prospect in Namibia.



The drilling tested an area of historical high-grade copper - vanadium mining carried out early last century at the Nosib Prospect, which is located at the western end of EPL3543, 20km southwest, along strike, from the Company's' Abenab high-grade Vanadium project, in the Otavi Mountain Land in Namibia (Figure 4).

Copper mineralisation was intersected in all 7 of the remaining holes, which, in addition to the previously announced intersections<sup>1</sup> means that all 15 holes in this RC drilling programme intersected significant copper mineralisation, with the majority of holes producing exceptional copper, lead and high-grade vanadium intersections, as well as increasing silver assays with depth.




Figure 1: Nosib Cross section 80,100mE with high-grade Copper-Lead-Vanadium-Silver intersections

The results from NSBRC010 include an exceptionally valuable intersection of 9m @ 3.66% Cu, 11.91% Pb, 3.62% V<sub>2</sub>O<sub>5</sub> and 7.70g/t Ag from only 3m down hole depth (see cross section, Figure 1 below).

Golden Deeps CEO, Jon Dugdale, commented "Nosib represents a significant new discovery for Golden Deeps. The high-grade copper, lead and vanadium mineralisation extends from surface, is open along strike and continues well into the footwall, at depth, below the previously developed mineralisation.

We see potential here to not only define a shallow, open-pitable, resource of copper, lead and vanadium but also for high-grade copper - silver mineralisation extending to depth.

The key next step is to do more drilling to extend this very exciting, high-value, multi-element discovery."




Figure 2: Longitudinal Projection through Nosib with drilling intersections and plunging copper-silver shoot

The current drilling at Nosib Block has tested the moderately north-dipping, mineralised, arenite/conglomerate unit between the three historically developed mining-levels (Figure 1), to a depth of only 60m to 80m below surface and a strike length of less than 80m (see longitudinal projection, Figure 2).

The historical No 2 shaft was developed on three levels to a depth of 120m from 1917 to 1920 but not mined. Golden Deeps' geologists accessed the three levels of the mine and took underground channel samples from the walls of the drives. Best channel results include:

NOUG0001 6m at 9.3% Cu, 4.72% Pb, 7.92g/t  $Ag^2$ NOUG0005 6m at 1.51% Cu, 10.59% Pb, 7.15g/t Ag, 1.12%  $V_2O_5^2$ 

The shallower high-grade copper intersections are generally enriched in lead and vanadium in the upper levels where circulating ground-waters are interpreted to have supergene-enriched vanadium and lead in association with the copper carbonates, malachite and azurite. Peak intersections produced in the shallow zone to date include, from this release:

- NSBRC010: 29m @ 1.54% Cu, 4.49% Pb, 1.19% V<sub>2</sub>O<sub>5</sub>, 6.97g/t Ag from 2m

- NSBRC013 31m @ 0.53% Cu, 3.32g/t Ag from 35m

incl. 3m @ 1.21% Cu, 7.07g/t Ag from 52m, and,

incl. 1m @ 3.37% Cu, 17.24g/t Ag from 36m

In addition, from the previous release (15 June 21)<sup>1</sup>:

NSBRC003 44m @ 0.74% Cu, 0.17% Pb, 4.37g/t Ag from 46m

incl. 1m @ 3.46% Cu, 18.9g/t Ag from 75m

This thick "shoot" of copper-silver mineralisation defines a steep northeast plunging zone that is open down plunge and along strike to the southwest and northeast (see longitudinal projection Figure 2). This zone is generally increasing in width and silver grade in proportion to copper grade with depth, indicating potential for Khusib Springs style, high-grade, copper-silver mineralisation down plunge.



Further drilling is planned to test two key targets at Nosib:




Figure 3: Nosib Block prospect, historical development & drillhole locations with projected copper mineralisation

- i) Extensions of the shallow, high-grade, copper-lead-vanadium mineralisation which is open along strike to the northeast and southwest (see plan view, Figure 3), and,
- ii) Deeper extensions of a developing high-grade copper-silver shoot, that may be the top of a Khusib Springs style high-grade mineralised zone.

#### About the Nosib Block and Khusib Springs drilling program:




Figure 4: Location plan EPL3543 showing the location of the main prospects

**Nosib** was one of two key target areas drill tested during the initial program that also tested shallow projections of the **Khusib Springs**<sup>3, 7</sup> deposit (see location Figure 4). A total of 25 reverse circulation (RC) holes for 1,275m were completed, including 10 holes for 331m at Khusib Springs and 15 holes for 958m at Nosib<sup>6</sup>. Results have now been received for all 15 of the holes of the Nosib program, producing significant intersections in all but 4 of the holes completed (including shallow holes that over-shot the mineralisation).

Table 1 includes all significant intersections calculated from the Nosib drilling results received to date.

Appendix 1, Table ii) includes Nosib Block and Khusib Springs drillhole details from this program.

At the **Khusib Springs** mine, that previously produced **300,000t at 10% Cu and 584g/t Ag<sup>4</sup>**, the RC drilling program tested for high-grade copper-silver mineralisation adjacent to the historic stopes and up plunge from orebodies mined underground. Previous intersections in these mined areas included:

KH006 4.5m at 35.19% Cu, 3.67% Pb, 2.23% Zn, 2090.91g/t Ag from 30m<sup>5</sup> KH008 14.0m at 8.12% Cu, 0.75% Pb, 0.52% Zn, 385.06g/t Ag from 37m<sup>5</sup>

Significant copper mineralisation (malachite, azurite and tennantite) was intersected in six of the holes drilled, including KHRC007 that intersected 10m of malachite, azurite and disseminated copper sulphides from 10m down-hole depth (8.6m below surface). Results from the drilling at Khusib Springs will be compiled when all results are received.

JORC Table 1, Sections 1 & 2 includes all details on the Nosib and Khusib Springs project and drilling program.

### **About the Nosib Block Copper-Silver-Lead-Vanadium Project**

The Nosib Block mine was a high-grade copper-vanadium mine located at the western end of EPL3543, 16km west of Khusib Springs and 20km along strike from the Company's Abenab high-grade Vanadium Project (Figure 3). Copper mineralisation was discovered at Nosib in 1915 with mine access development work between 1917 to 1920. The historical No 2 shaft was developed on three levels to a depth of 120m but not mined. Golden Deeps' geologists accessed the three levels of the mine and took underground channel samples from the walls of the drives. Best channel results include:

NOUG0001 6m at 9.3% Cu, 4.72% Pb, 7.92g/t Ag<sup>2</sup>

NOUG0005 6m at 1.51% Cu, 10.59% Pb, 7.15g/t Ag, 1.12%  $V_2O_5^2$ 

The high-grade copper-silver-vanadium-lead mineralisation dips moderately to the north and is hosted by conglomerate and sandstone/arenite (mine sequence) in contact with dolomite to the north and basement granite to the south. The mineralisation shows good continuity and remains in-situ because the areas



between the development drives were not mined. The drilling at Nosib tested between the previously developed levels, targeting extensions to the high-grade copper-lead-silver-vanadium ore that was channel sampled.

#### **About the Khusib Springs Copper-Silver Project**

The Khusib Springs copper-silver mine is located on EPL3543 near the town of Grootfontein in Namibia (Figure 4). Khusib Springs was a very high-grade copper-silver mine which produced approximately **300,000t of ore grading 10% Cu, 1.8% Pb and 584g/t Ag**<sup>1</sup>. Previous drill intersections at Khusib Springs include:

KH006 4.5m at 35.19% Cu, 3.67% Pb, 2.23% Zn, 2090.91g/t Ag from 30m<sup>5</sup> KH008 14.0m at 8.12% Cu, 0.75% Pb, 0.52% Zn, 385.06g/t Ag from 37m<sup>5</sup>

Khusib Springs was mined between 1996 and 2003 after which it closed due to the very low copper price at the time and depletion of easily minable high-grade ore. At the beginning of 2003, towards the end of mining, the copper price had fallen to US\$1,500 per tonne (now nearly US\$10,000 per tonne).

The Khusib Springs mine is considered analogous with the Tsumeb Mine 40km to the northwest that between 1905 and 1996 produced **30Mt of ore grading 4.3% Cu, 10% Pb and 3.5% Zn**<sup>6</sup>:

In late 2020, Golden Deeps engaged South Africa based geological consultancy Shango Solutions to complete a study on Khusib Springs to validate the historic drilling data and digitally capture hardcopy mine plans including underground development and stoping plans with a view to assess the potential for further minable ore remaining in the mine. The study was completed by Shango in January 2021.




Figure 5: Cross section of Khusib Springs Mine showing developed and stoped areas and un-mined zones

The study demonstrates that there are remanent zones of copper-silver mineralisation on the margins of the mined stopes as well as at depth (Figure 5). The remnant ore on the margins of the stopes was probably



left because of the grade in the light of the then prevailing low copper prices. Copper mineralisation has been mapped in a small working at the surface above the deposit.

The current drilling program at Khusib Springs targeted the upper part of the deposit adjacent to the old stopes and up-plunge from previously mined high-grade areas.

Deeper targets, including the discovered but not mined Khusib Deeps (see Figure 5 below) will be drill tested in subsequent drilling programs, with the objective of finding a new high-grade copper-silver deposit of similar grade to that historically mined at Khusib Springs. Targeting will be refined through review and possible re-interpretation and modelling of previous drilling and geophysics.
