Prospect Resources Ltd (ASX: PSC, FRA:5E8) ("Prospect" or "the Company") is pleased to advise that at the General Meeting held today at 10:30am (AWST), shareholders of the Company passed all Resolutions set out in the Notice of Meeting dated 25 May 2021 by way of poll.

In accordance with ASX Listing Rule 3.13.2 and Section 251AA(2) of the Corporations Act a summary of the proxy votes received and voting results on each Resolution is attached.

**Prospect Managing Director, Sam Hosack, said**: "I am extremely pleased to announce the strong support we received from our shareholders for all resolutions and in particular, the highly accretive Farvic transaction. We now look to execute the agreement over the coming month. In completing the Farvic transaction there is an immediate benefit to Prospect shareholders as they own an additional 17% of the quality Arcadia Lithium project, which will have a major positive impact on our funding of the Arcadia Lithium project."

"With the Pilot Plant production now underway, we are on target to ship on specification technical product before end of June, and commence the final customer qualification processes. We remain in a strong cash position as we finalise the optimised feasibility by Lycopodium and advance funding discussions to develop Arcadia."
