## **RETRACTION OF CERTAIN STATEMENTS**

**Arcadia Minerals Ltd (ASX:AM7) (Arcadia or the Company)** refers to an advertorial article published in the Australian Financial Review on Wednesday, 30 June 2021 titled "Tapping Africa's tantalising potential" (Advertorial Article).

The Advertorial Article included statements that:

- Set out plans and costings for a mine

(Collectively, the "Statements")

The statements comprise forecast financial information for the purposes of the ASX listing rules.

The Company formally withdraws the Statements as set out in the Advertorial Article and notes that:

- Forecast financial information of expected capital expenditure and life of mine contained in the statements were not reported in accordance with the requirements of the ASX Listing Rules in that all the material statements on which the targets are based and all the material assumptions on which the forecast financial information are based were not declared;
- The Company does not have a reasonable basis that is consistent with the requirements of ASIC Regulatory Guide 170 and Information Statement 214 for forward looking statements contained in the Statements or published in accordance with the requirements of the JORC Code/Chapter 5
- Investors should not rely on the Statements as a basis for any investment decision concerning the Company.
