

Option Expiry Notice – ZMMOB Options Expiring 13 August 2021

ASX RELEASE 13 July 2021

Zimi Ltd (ASX:ZMM) ("Zimi", the "Company") advises that the Company's listed options "ZMMOB" \$0.125 cent options expire on 13 August 2021.

The Company advises that the listed options are out of the money, and pursuant to the provisions of paragraph 5.4 of Appendix 6A of the ASX Listing Rules, option expiry notices will not be sent to individual option holders. The sample notice attached was not sent out to option holders due to the options being substantially out of the money.

The Company provides the following information:

- a) The total number of options expiring on 13 August 2021 is 43,619,911. One fully paid ordinary share would be issued upon exercise of each option;
- b) The exercise price is \$0.125 (12.5 cents);
- c) The due date for payment if exercising the options is 13 August 2021;
- d) The consequences of non-payment of the exercise price of the options by 5:00pm WST on 13 August 2021 is that the options will automatically lapse;
- e) The date that quotation of the options will end is 9 August 2021 (at the close of trading on that date);
- f) The latest available market price of the Company's fully paid ordinary shares (at 12 July 2021) was \$0.017 (1.7 cents);
- g) The highest market price of shares in the three months immediately preceding this announcement was \$0.022 (2.2 cents) on 29 April 2021 and 31 May 2021;
- h) The lowest market price of shares in the three months immediately preceding this announcement was \$0.014 (1.4 cents) on 30 June 2021; and
- i) No underwriting agreement has been notified under Listing Rule 3.11.3.
