The company has secured bank facility from NAB which includes:

- 1. a \$6.5m equipment finance loan at an improved fixed 4.2% interest; this facility is to replace the existing Greensil facility. The equipment finance loan is secured over all of the company's assets and will be over a 5-year term.
- \$1.0m invoice finance facility at 6.22% interest is secured over all of the company's assets and reviewed by annually on an ongoing basis; this facility will be used for working capital.
