	Answer: Yes, given the Company is an exploration company and not generating any revenue (other than interest income) it is expected that it will continue to have negative operating cash flows for the time being. The Group also conducted a sizeable drill program in the March Quarter which significantly increased spending. The proposed outgoings for the next quarter will be reduced.

	Answer: The Company has facilities in place to secure further funding based upon ongoing satisfactory exploration results. The Company also retains the majority of its placement capacity under listing Rule 7.1 and 7.1A.
