APPENDIX 4C AND REPORT ON QUARTERLY ACTIVITIES

Sydney, Australia, 30th June 2021: Victor Group Holdings (ASX:VIG) (“VIG” or “the Company”), releases its cash flow report for the June 2021 quarter (Appendix 4C) and provides an update on the key areas of activity during the quarter ended 30 June 2021.

Principal Activities

VIG and its controlled entities (the “Group”) provides:

- SaaS, IaaS & PaaS services to customers;
- Education cloud platforms which bring together best-in-class resources and applications from strategic partners such as education service and e-learning content providers; and
- A wide range of e-learning solutions for educational institutions, students and parents.

Key areas of activity during the quarter:

- SaaS & PaaS service in PRC – VIG operates its cloud services and software development in PRC through its subsidiary, Shenghan (known as Wenhan, company name changed on 20th August 2020). During the quarter, Shenghan collected over \$5.54 million receivables. Approximately \$1.25 million cash inflow came from the sales of software inventory. The company spent \$1.55 million on the purchase of the intelligent power supply system which was disclosed in the last quarter. The full amount of has been paid as at the end of June and the power supply system has been settled and delivered on 3rd June 2021. The cash and cash equivalents position of Shenghan has increased significantly during this quarter due to the strong collection of receivables. The Group believes the cash flow of the SaaS & PaaS business will remain healthy in the foreseeable future.
- E-learning and cloud education – Shenghan still contributed most of the revenue and cash inflow of the E-learning business during the quarter. The company collected approximately \$1 million in receivables and achieved circa \$764K in sales. The management recognises the recent changes in policy and regulatory environment with K12 educations in the PRC, and after further assessment conducted by the management team, the new rules showed less of an impact on our current business model as most of the E-learning content VIG offers predominately focuses on vocational education or non-disciplinary training within the school. The management believes there will be further development in these areas of learning, as the PRC government aims to reduce the burden on students.



- A summary of revenue and expenditure (cash basis) incurred in respect of the Company's business activities is as follows:

The cash flow from SaaS & PaaS segment remained healthy during the quarter. The cash inflow of E-learning & online education business was still incurred in the PRC.

- The Company continues exploring acquisition opportunities of businesses in Australian education industry which will have a synergistic effect with VIG's existing e-learning business and have the potential to further strengthen the Company's offerings through better serving overseas and local students and trainees who use VIG's cloud education. One of the key goals of the Company is to increase the e-learning content provided to increase VIG's brand, value, and reputation in the marketplace.

Comment on Appendix 4C Cash Flow Report

The turnover of accounts receivable has increased significantly due to the wider economic recovery. The Group does not plan to increase the capital expenditure in the next quarter. The Group anticipates its cash flow will remain healthy and the E-learning & online education business will contribute more to the Group's financial position.

Related Party Payments

The June 2021 report includes \$6,400 director's fee paid to the chairman of the Board.
