	Answer: <i>The Company expects to have a similar level of net operating cash flows for the next quarter however will review ongoing activities and has the ability to adjust expenditure according to available funding, if necessary.</i>

	Answer: <i>The Company advises that it is currently in a trading halt in order to consider, plan and execute a capital raising, noting that it has all of its LR7.1 capacity available and all of its LR7.1A capacity available, if required. The Directors also have a strong track record of being able to raise funds. In addition to that, the Company will continue to monitor its available cash levels and can reduce its operating and exploration expenditure going forward, if needed.</i>
