

## Jewell Well Operational Update

**Perth, Western Australia – 9<sup>TH</sup> August 2021 – Stonehorse Energy Limited (ASX: SHE)** is pleased to provide shareholders and investors with an update on well operations regarding the drilling of the Jewell 1-13-12 SXH well (**Jewell Well**) located in Carter County, Oklahoma in North America's Anadarko Basin.

Pre-completion activities have finished and Liberty Oilfield Services (**Liberty**) are now on the Jewell well site and rigging up ahead of the commencement of completion operations (Figure 1).

In addition, the construction of the gas pipeline from the Jewell Well to the main sales line is on schedule and nearing completion. Liberty will commence well completion operations, including multi-stage stimulation of the lateral portion of the wellbore immediately.
