Directors' Report

Your Directors present their report, together with the interim financial report of Schrole Group Ltd ("the Company") and controlled entities ("the Group", "Schrole") for the half year ended 30 June 2021.

Principal Activities

The principal continuing activities of the Group during the half-year was the provision of software solutions primarily to the education sector and provision of training services.

Review of Operations

Schrole Group Ltd reported an improved position for the half year ended 30 June 2021 with the loss of \$706,755 (2020: loss of \$934,677) being a 24% improvement on the previous corresponding period. Lower revenues of \$2,718,772, reflecting the impact of the COVID-19 pandemic on subscription renewal rates from international schools in the second half of 2020, are offset by increased margins as a result of the renegotiation of the arrangement with ISS and the continued strong focus on cost control during the period.

During the half year ended 30 June 2021, Schrole's increased investment in people, platforms and product is enabling the Company to progress its vision of transitioning to full global HR SaaS for teachers and educational organisations. The successful release on 1 July 2021 of Schrole Connect 3.0 is the first part of a series of planned upgrades and releases of the Schrole HR SaaS suite. Schrole HR will integrate Schrole's current and new product offerings to provide a full suite of human resources Software as-a-Service (SaaS) offerings, comprising Schrole Connect, Verify, Engage, Cover and Develop. Schrole HR creates significant cross and upsell revenue growth opportunities.

Schrole continues to strengthen its market position in the domestic and international school sector, with over 600 school customers. Schrole Community, a leading indicator of future revenue, achieved a record high of 187,938 community members as at 30 June 2021. This represents a 21% growth in numbers over the 12-month period.

Schrole Connect

With 386 schools actively engaged on the Connect platform as at 30 June 2021, including a growing number of school groups, Schrole continues to experience positive renewal rates from existing international school clients, strong new sales, the return of some schools who let subscriptions lapse amidst the uncertainty of the pandemic and improved engagement with the platform. Connect school customers have increased by 10% from a low of 350 schools in September 2020, to 386 schools at the end of June. This was supported by a renewal rate of 81% and strong sales of 68 licences including a group sale of 20 licences to Aldar Education in the United Arab Emirates over the period from January to June 2021. A significant upgrade (Connect 3.0) was released with new functionality and enhanced existing features on 1 July 2021, which has been well received by customers.



The termination of the agreement with ISS is seeing a successful transition with strong customer renewals and an expansion in Schrole's share of margin. Over the 24-month transitional period, the share of revenues is:

- 12 months to 30 June 2021: 50-50 share of new sales and renewals
- 12 months to 30 June 2022: 50-50 share of renewals, 100% of new Schrole sales to Schrole
- Sharing of any sales/revenues terminates on 30 June 2022

Schrole Cover

Schrole Cover, a cloud-based SaaS platform for the fast filling of casual staffing positions, continued its expansion into schools in Western Australia with further sales to new schools and additional hospital clients during the half-year. Interest is growing from international schools, who are familiar with Connect and keen to explore additional Schrole products, resulting in the first international sale to a school in Japan in June.

Schrole Verify

The demand for Schrole Verify continues to increase globally as schools are increasingly compelled to undertake reference checks for their existing and prospective teachers as well as for non-teaching staff members. Throughout the half-year sales were made to schools in a range of locations including China, Qatar, Brazil, Hong Kong, Indonesia, Philippines, Japan and Ethiopia. This product is proving a strong 'cross sell' for existing customers.

Schrole Develop

Schrole Develop is the consulting and training division of the Company, providing nationally recognised training qualifications in training, leadership and management to major multinational mining companies and government agencies in Western Australia. Sales during the half-year recovered relative to the pandemic affected prior period. The International Diploma in Leadership & Management contextualised for delivery to international schools continues to grow in profile, with delivery to the Cognita group of schools commencing in May 2021.

Schrole Group Ltd Notes to the Consolidated Financial Statements

Note 1. Reporting Entity

The interim financial report (**Report**) of Schrole Group Ltd (**Company**) and its controlled entities (**Group or Consolidated Entity**) for the half year ended 30 June 2021 was authorised for issue in accordance with a resolution of the Directors on 30 August 2021.

Schrole Group Ltd is a listed public company, trading on the Australia Securities Exchange, limited by shares, incorporated and domiciled in Australia.

The Group's principal place of business and registered office is located at Ground Floor, 142 Hasler Road, Osborne Park WA 6017.

Note 2. Basis of Preparation

This Report for the half-year ended 30 June 2021 has been prepared in accordance with the Corporations Act 2001, AASB 134 *Interim Financial Reporting* and other applicable accounting standards, Accounting Interpretations and other authoritative pronouncements of the Australian Accounting Standards Board. Compliance with AASB 134 ensures compliance with IAS 34 'Interim Financial Reporting'.

This Report does not include all the notes of the type normally included in an annual financial report. Accordingly, this report is to be read in conjunction with the annual report for the year ended 31 December 2020 and any public announcements made by Schrole Group Limited during the interim reporting period in accordance with the continuous disclosure requirements of the Corporations Act 2001.

The Report has been prepared on an accruals basis and is based on historical costs modified by the revaluation of selected non-current assets, financial assets and financial liabilities for which the fair value basis of accounting has been applied.

The Report does not include full disclosures of the type normally included in an annual financial report. For the purposes of preparing the interim financial statements, the half-year has been treated as a discrete reporting period.

The accounting policies adopted are consistent with those adopted and disclosed in the Company's 2020 Annual Report for the year ended 31 December 2020, unless otherwise stated.

This Report has been prepared on a going concern basis, based on the Group's expected future financial performance and in particular the cash flow and profitability benefits that are expected to arise for the Group.

For the period ended 30 June 2021, the Group incurred a net loss of \$706,755 and experienced net cash outflows from operations of \$1,321,548. As at 30 June 2021, the Group had net assets of \$1,868,328 and cash balance of \$3,276,194.

The ability of the Group to continue as a going concern is dependent on the Group either achieving expected rates of renewals and securing forecast new sales of software subscription contracts and there being continued strong demand for its training services. The financial statements have been prepared on a going concern basis, which contemplates the continuity of normal business activity, the realisation of assets, settlement of liabilities through the normal course of business including the presumption that sufficient funds



will be available to finance the operations of the Group. As at the date of this report, management believes that there are sufficient funds available to continue to meet the Group's working capital requirements and support planned technical and product development and cross selling initiatives, to underpin the Group's future growth.

New, Revised or Amended Accounting Standards and Interpretations Applicable

In the half-year ended 30 June 2021, the Directors have reviewed all of the new and revised Standards and Interpretations issued by the AASB that are relevant to the Group and effective for the half-year reporting periods beginning on or after 1 January 2021. There was no material impact on the financial statements.

On 27 August 2020, following satisfaction of this milestone, the Company issued an aggregate of 93,000,000 Shares on conversion of the Series B Performance Shares (Conversion Shares) to the holders of the Series B performance shares (Recipients). Through no admission of liability on behalf of the Company or the Recipients and following discussions with the Recipients, the Company entered into deeds of cancellation with each of the Recipients, pursuant to which the parties agreed that, subject to shareholder approval, the 93,000,000 Conversion Shares would be cancelled. It was resolved at a General Meeting on 12 February 2021 that the 93,000,000 Conversion Shares be cancelled and accordingly, the Conversion Shares were cancelled on 26 February 2021.
- c. Series C performance shares that convert into an equal number of ordinary shares once the company achieves EBITDA of \$3,000,000 over any 12-month period prior to 48 months of admission onto the ASX. It was resolved at a General Meeting on 31 May 2021 that the 150,000,000 Conversion Shares be cancelled and accordingly, the Conversion Shares were cancelled on 17 June 2021.

Consequently, as at 30 June 2021 there were no performance shares on issue.

Performance Rights

On 3 July 2018, pursuant to the Company's Employee Securities Incentive Plan, Schrole Group issued a total of 45,200,000 performance rights to current employees of the Company and its wholly-owned subsidiaries with the following terms:

- a. 9,040,000 Tranche A performance rights vesting once the Company achieves 215 school subscriptions to Schrole Connect or 198 subscription licences to Schrole Cover within 18 months of admission onto the ASX. On 27 September 2018, the Tranche A performance rights vested following satisfaction of this milestone. Accordingly, \$153,680 share based payment expense was recorded for the year to 31 December 2018 in relation to the issue of the Tranche A performance rights. Subsequently the Company has issued 7,700,000 ordinary shares on the exercise of the same number of Tranche A performance rights, with the remainder yet to convert to ordinary share capital.
- b. 13,560,000 Tranche B performance rights vesting once the Company achieves sales revenue of \$7,000,000 over any 12-month period prior to 36 months of admission onto the ASX. During the year ended 31 December 2020, the Tranche B performance rights vested following satisfaction of the milestone. Accordingly, \$86,190 share based payment expense was recorded in relation to the issue of the Tranche B performance rights. Subsequently, the Company has entered into deeds of cancellation with each of the holders of the Tranche B performance rights, pursuant to which the



- parties have agreed that the 5,070,000 Tranche B performance rights would be cancelled. The Tranche B performance rights were cancelled on 16 February 2021.
- c. 22,600,000 Tranche C performance rights vesting once the Company achieves EBITDA of \$3,000,000 over any 12-month period prior to 48 months of admission onto the ASX. As at the date of issue, management assessed the number of performance shares that are expected to vest as 0% for Tranche C performance rights.

On 29 March 2021, pursuant to the Company's Employee Securities Incentive Plan, Schrole Group issued a total of 12,714,641 Tranche D performance rights to current employees of the Company and its whollyowned subsidiaries as bonuses. Subsequently the Company has issued 7,983,567 ordinary shares on the exercise of the same number of Tranche D performance rights, with the remainder yet to convert to ordinary share capital.

Pursuant to a resolution at the 31 May 2021 Annual General Meeting, approval was granted to issue 133,800,000 options to the Company's Managing Director with the following terms:

- a. 30,000,000 Class A performance rights vesting once the Company achieves release of three Schrole HR software modules prior to 30 September 2021, 31 December 2021 and 31 March 2022 respectively. As at 30 June 2021, management has assessed the number of performance shares that are expected to vest as 100% for Class A performance rights.
- b. 36,000,000 Class B performance rights vesting once the company achieves revenue of between \$6,000,000 and \$8,000,000 in any 12-month period to December 2022. As at 30 June 2021, management has assessed the number of performance shares that are expected to vest as between 60% and 90% for Class B performance rights.
- c. 26,400,000 Class C performance rights vesting once the company achieves revenue for the year ended 31 December 2023 of between \$10,000,000 and \$12,000,000. As at 30 June 2021, management has assessed the number of performance shares that are expected to vest as 25% for Class C performance rights.
- d. 13,200,000 Class D performance rights vesting one the company achieves a 30 day VWAP exceeding \$0.03
- e. 13,200,000 Class E performance rights vesting one the company achieves a 30 day VWAP exceeding \$0.045
- f. 15,000,000 Class D performance rights vesting one the company achieves a 30 day VWAP exceeding \$0.06
