## **Skin Elements secures TGA Registration for Invisi Shield SuprCuvr**

### **Highlights**

- Skin Elements has secured Therapeutic Goods Administration (TGA) registration of Invisi Shield SuprCuvr as a Hospital Grade Disinfectant
- Invisi Shield SuprCuvr is now listed on TGA's Australian Register of Therapeutic Goods (ARTG) – the register of therapeutic goods that can be lawfully supplied in Australia
- Invisi Shield SuprCuvr has 99.99999% (7 log reduction<sup>1</sup>) effectiveness against COVID 19 coronavirus
- Skin Elements will now move to aggressively pursue and execute commercial-scale sales and distribution opportunities for Invisi Shield SuprCuvr
- Invisi Shield SuprCuvr has also been certified as an Input for Organic Production by the National Association for Sustainable Agriculture Australia (NASAA) Organic and Biodynamic Standard

Australian natural skin care company Skin Elements Limited (ASX: SKN) (Skin Elements, the Company) is pleased to announce that it has secured Therapeutic Goods Administration (TGA) registration for its Invisi Shield SuprCuvr (AUST-L 373328) (Invisi Shield) as a Hospital-Grade disinfectant product.

Invisi Shield SuprCuvr has been issued with an ARTG (Australian Register of Therapeutic Goods) number, 373328. The ARTG is the register of therapeutic goods that can be lawfully supplied in Australia.

Invisi Shield SuprCuvr has 99.99999% (7 log reduction<sup>1</sup>) effectiveness against COVID 19, confirmed by independent laboratory testing by Eurofins AMS Laboratories Pty Ltd<sup>2</sup> to satisfy TGA requirements. Skin Elements' research indicates that Invisi Shield is the first and only approved disinfectant globally with a 99.99999% (7 log reduction<sup>1</sup>) efficacy against COVID 19. This is a substantial difference from what is currently on the market, as Log 7 reduction is 10 times greater than Log 6 reduction (99.9999%), 100 times greater than Log 5 (99.999%), 1,000 times greater than Log 4 (99.99%) and 10,000 times greater than Log 3 (99.9%).

The combination of world-leading, extremely high efficacy in a 100% plant-based formula presents a significant market opportunity for Invisi Shield in large-scale settings where disinfectants are deployed.

Invisi Shield SuprCuvr has benefited from more than 15 years research and development by the Skin Elements' team in the area of plant-based ingredients and antimicrobials. It is Australian made from

a 100% plant-based, proprietary formula that is biodegradable, vegan, non-corrosive, non-flammable, and is cruelty-free (not tested on animals).

It does not contain benzalkonium chloride, hydrogen peroxides, quaternary ammonium compounds, bleach/chlorine compounds or other typical chemical ingredients of disinfectant products.

With the TGA registration, Invisi Shield SuprCuvr is now approved for use in hospitals and aged-care homes which are restricted to using only TGA registered disinfectants. Other sectors that are ideal for the product are hotels, offices, airports, public transport hubs and for home use.

The TGA registration of Invisi Shield SuprCuvr represents a major milestone in the product's development timeline. It allows Skin Elements to now make detailed and specific product and label claims in respect of Invisi Shield SuprCuvr.

It also paves the way for Skin Elements to commence its commercialisation and growth strategy for Invisi Shield SuprCuvr. This involves pursuing and executing commercial-scale sales and distribution opportunities for Invisi Shield with distributors and other potential sales partners who stipulate TGA registration as pre-requisite in the disinfectant products they deal in. This will be a core focus for the Company.

Skin Elements' Executive Chairman Mr Peter Malone said:

*"We are delighted to have secured registration for Invisi Shield SuprCuvr with the Therapeutic Goods Administration as a Hospital-Grade Disinfectant. We see the potential to provide an efficacious, 100% plant-based disinfectant in large commercial settings as a major opportunity for Invisi Shield® SuprCuvr and the Company. With TGA registration now in place, we plan to aggressively drive our sales and distribution plans for Invisi Shield SuprCuvr with the aim of delivering revenues to the Company, and value for shareholders."*

#### **Invisi Shield Granted Organic Certification**

Skin Elements is also pleased to advise that Invisi Shield SuprCuvr has been certified by NASAA (National Association for Sustainable Agriculture Australia) Organic and Biodynamic Standard as an Input for Organic Production (Certification Number 6405M).
