# **Change of reporting currency**

Vulcan Energy Resources Limited (ASX:VUL, FRA:6KO, "Vulcan" or "the Company") today advises that the presentation currency of Vulcan has changed to Euro from Australian dollars, effective from the commencement of the 2022 Financial Year.

This change means that the financial information in the Company's Quarterly ASX reports, as well as its Half-Year and Full-Year Accounts, will be presented in Euro.

Given the focus of Vulcan's activities on the European market, its recent acquisitions of several German-based operating entities and its planned operations in Europe from which Vulcan will generate the majority of its revenue and costs, the Company believes this change will provide shareholders with a more accurate reflection of its underlying performance.

The restated Consolidated Statement of Profit or Loss and Other Comprehensive Income and Consolidated Statement of Financial Position for the Financial Year ended 30 June 2021 are expected to be reported as comparative information for the 2021/2022 reporting year.
