Issue of Tranche 2 Shares & Cleansing Notice

Telecommunications innovator Vonex Limited ("Vonex" or the "Company") (ASX: VN8) is pleased to advise that, further to the announcement dated 23 July 2021, it has today issued the Tranche 2 Placement shares, consisting of 86,588,857 ordinary shares at an issue price of \$0.11 per share to raise ~\$9.525m (before costs). The shares were issued to new and existing professional and sophisticated investors (**Placement Shares**).

Following the issue of the Placement Shares, the Company has ~\$11.4 million cash on hand is fully funded to execute its growth initiatives, including the various cross-selling opportunities via the recent transformational acquisition of part of MNF Group's Direct Business, which services small-to-medium enterprise and consumer customers across Australia.
