STRONG DRILLING RESULTS HIGHLIGHT POTENTIAL TO GROW INVENTORY AND MINE LIFE AT ZOROASTRIAN

Lodes extended at depth and along strike while high-grade in-fill drilling results show scope to increase Ore Reserves

Key Points:

- Exploration (extensional) drilling confirms the mineralisation extends for more than 150m below the existing Resource at both the Blueys South and Zoroastrian South lodes
- Drilling also extends the known mineralisation along strike at the Blueys and Royal Mint lodes
- The latest results include:
 - o 6m @ 2.44g/t Au from 460m in KND210001
 - o 1m @ 11.7g/t Au from 466m in KND210003
 - 4.5m @ 3.53g/t Au from 102m in KND210007
- Resource definition drilling returns grades which exceed those in the Resource model, highlighting potential for increases in the Zoroastrian Ore Reserve. Results include:
 - 5.2m @ 4.97g/t Au from 379m including 1.69m @ 14.1g/t Au from 381.62m in KND210007
- Zoroastrian hosts underground Ore Reserves of 98,000oz @ 3.6g/t for a three-year mine life; There
 is a total of 530,000oz at 2.2g/t in the Indicated and Inferred Mineral Resource category
- "These results support our view that there is immense potential to grow the inventory and mine life at Zoroastrian through extensions to the known mineralisation at depth and in new areas." Bardoc Chief Executive Robert Ryan

Bardoc Gold Limited (ASX: **BDC**, **Bardoc** or **the Company**) is pleased to report more strong drilling results which highlight the scope for further growth in the gold inventory at the Zoroastrian deposit within its 100%-owned Bardoc Gold Project near Kalgoorlie.

The Bardoc Gold Project has Ore Reserves of 1Moz within a total Resource of 3.07Moz.

The initial drilling results have extended the known mineralisation a further 150m down-plunge from the existing high-grade Mineral Resource. These extensions and the successful resource definition drilling results



have improved the likelihood of being able to increase Mineral Resources and Ore Reserves at Zoroastrian once the resource modelling and mine planning work is completed.

MANAGEMENT COMMENTS

Bardoc Chief Executive Robert Ryan said: "These results support our view that there is immense potential to grow the inventory and mine life at Zoroastrian through extensions to the known mineralization at depth and in new areas.

"The diamond drilling program we commenced in August has already confirmed the presence of mineralisation 150m below the current Resource envelope, providing strong evidence for what we have long suspected – that the multi-lode system at Zoroastrian extends at depth.

"In addition to the immediate opportunity to grow the Resource and Reserve, this also highlights the future opportunity to continue to grow the deposit from underground drilling positions.

"The results are considered particularly important because increases in the inventory and mine life at one of our three cornerstone deposits will further improve the Project's forecast financial returns and support the optimised mine plan we announced recently.

"Drilling is continuing at Zoroastrian and we look forward to incorporating the results into an updated Resource model. This work will continue in parallel with ongoing work towards achieving a Final Investment Decision by the end of this year."

ZOROASTRIAN DRILLING EXTENDS DEPTH AND GRADE

The recent and ongoing drilling at Zoroastrian has had two key objectives:

- Extend mineralisation at depth and along strike
- Increase confidence in the material outside of Reserves.

Depth and Strike Extensions

The depth extent of the Blueys South and Zoroastrian South lodes has been tested and confirmed by deep diamond core drilling. The results have shown that both of these lodes, the basis of the current mining Reserves of 98koz Au @ 3.6g/t Au, continue at depth.

These holes have intersected the Blueys South and Zoroastrian South lodes about **150m down-plunge of the existing Mineral Resource**. This knowledge gives confidence in the ongoing exploration work with increases in Resources and Reserves possible after the requisite modelling and mining studies.

The intercepts reported in core holes KND210001-3, amongst others, are:

- 6m @ 2.44g/t Au from 460m in KND210001
- 1m @ 11.7g/t Au from 466m in KND210003

These results are in line with the overall resource grade of 2.2g/t Au and, most importantly, they have allowed the Company's geologists to refine the target area of the highly mineralised fractionated dolerite unit.

Experience from the upper levels of the ore body suggests that the holes are close to the high-grade ore zone and they have confirmed that the Blueys South and Zoroastrian South Lodes both continue at depth with the lodes projected to intersect the fractionated dolerite nearby, providing an area for long-term exploration.



RC drill-hole KNC210006 was drilled to test for strike extensions of the Zoroastrian South Lode at depth, in an interpreted position of the fractionated dolerite.

The hole is about 120m south of the planned underground workings and was successful and intersected 4m @ 4.37g/t Au from 144m. The results of this hole, encountering both the fractionated dolerite and the Zoroastrian South structure, will require further exploration drilling.

Resource Definition & Strike Extensions

Diamond core drilling, located at the southern end of the existing Zoroastrian Central open pit, is designed to test for high-grade mineralisation within the Zoroastrian South Lode, as well as targeting resource strike extensions in Royal Mint and Blueys.

The Resource definition targeted mineralisation that is in the Inferred category and the drilling will potentially increase the confidence level of the resource model to Indicated. The significance of this is that Indicated material can be classified as an Ore Reserve.

The Zoroastrian South Lode, successfully intersected in KND210007, which returned an intercept of **5.2m @ 4.97g/t Au** from 379m including **1.69m @ 14.1g/t Au** from 381.62m, is significant as it is of **higher grade than** was **expected** in the existing resource model.

An updated Mineral Resource model will be completed after the completion of the current drilling program (scheduled for late 2021) and this upgraded area may lead to increased Ore Reserves and mine life.

The hole was also targeting strike extensions to Blueys and Royal Mint. The drilling was targeting areas close to proposed mine development that will potentially increase the resource and add additional ounces to the mine plan. Results from the extensions are:

- Blueys South 0.89m @ 4.91g/t Au from 298.3m in KND210007
- Royal Mint 4.5m @ 3.53g/t Au from 102m in KND210007

The drilling program has just deployed an extra drill shift to ensure the timely completion of the program with drilling due for completion in late 2021, paving the way for updated Mineral Resource model in early 2022 which will likely include additional Indicated material as well as depth extensions to the known Resource.






Figure 1: Zoroastrian drill hole location plan






Figure 2: Long section of Zoroastrian South Lode looking west. Note that this is only one of the multiple lodes being accessed from the same underground decline access.




Figure 3: 0.23m @ 42g/t Au within a broader intersection of 1.69m @ 14.1g/t core in KND210007

ZOROASTRIAN POTENTIAL

On 2 August 2021 an ASX announcement, "Bardoc Targets Substantial Resource Increase With New Drilling Program Underway At Zoroastrian" defined an Exploration target at Zoroastrian targeting two lode positions.

This Exploration Target of 2.05Mt - 2.59Mt at a grade of 3.4g/t - 4.2g/t for **225koz Au to 336koz Au** is the culmination of detailed geological work and it is proposed to commence testing it in late 2021. Full details can be obtained from the 2 August 2021 announcement and the targeted areas can be viewed in the diagram



below, as can be seen they are north and south of the planned underground mine design. An initial drill program at the north end of the pit shows promising results with more work being planned.

Exploration Target: The potential quantities and grades are conceptual in nature and there has been insufficient exploration to date to define a Mineral Resource. It is not certain that further exploration will result in the determination of a Mineral Resource under the "Australasian Code for Reporting of Exploration Results, Mineral Resources and Ore Reserves, the JORC Code" (JORC 2012). The Exploration Target is not being reported as part of any Mineral Resource or Ore Reserve




Figure 6: Oblique view of Zoroastrian looking north-west. Showing DFS pit designs, underground design and known lodes.

- Core drilling at Zoroastrian is ongoing for several months.
- Work with GR Engineering on refining final process plant designs.
- Water borefield final designs in September.
- Tenders for open pit and underground mining to be sent out in September.

BARDOC GOLD PROJECT - BACKGROUND

The Bardoc Gold Project runs contiguously north for 40km in the Eastern Goldfields. There are four main deposits and a multitude of smaller projects within the 250km² land-holding, providing a large Resource base and excellent exploration potential within the prolific Norseman-Wiluna greenstone belt and junction of the Bardoc Tectonic Zone (BTZ) and the Black Flag Fault (BFF).

These two deep-seated crustal structures host many multi-million-ounce deposits, including the world-renowned Golden Mile in Kalgoorlie.






Figure 8: Bardoc Gold Project, tenement location plan.




Figure 9: Project Location Plan
