**HSBC Holdings plc:**

**Notification of Disclosure Amendment – S671B, Corporations Act 2001**

We would like to inform you of a Change of Interests of substantial Holder by HSBC Holdings plc (HSBC) under Section 671B of the Corporations Act 2001, in relation to two HSBC Substantial Shareholder Disclosures, Cradle Resources Limited and Pharmaxis Limited.

During an internal review, which commenced in May 2021, of the 'Corporate Director role' undertaken by certain HSBC entities looking at Chain of Controlled undertakings and with external counsel guidance, we understand that the holdings of a Trust's interests in Australian stocks should be reported as Group aggregated holdings and in the name of HSBC. This differs from the approach taken to date, whereby substantial shareholder disclosures in Australia have been made at the Trust Underlying Company (TUC) level.

As a result, over the summer HSBC revisited prior disclosures and with input from external counsel determined that two corrective disclosures are required. These should have been reported at HSBC Holdings Plc level, whereas we have previously reported these to you at the TUC level in 2016 and 2019 respectively.

We can confirm that no trading activity has been undertaken in either stock since the original disclosures were filed. However, there has been a change in Legal Entity ownership for both issuers, which is also reflected in the corrective disclosure forms.

Separately, through the process of updating the disclosures, we became aware that in December 2020 there was a decrease to the Issued Share Capital (ISC) for Cradle Resources Limited. The shares held by HSBC have not changed during this time, but the percentage holdings have increased from 10.85% to 13.23%. The filing regarding this increase was not made on a T+2 basis due to an error on the third party system used by HSBC for monitoring which came to light via external counsel who used a different source when drafting the updated disclosures. As far as we are aware this was an isolated incident relating to this issuer and the system has since been updated.
