- Construction and modular assembly of pipe rack modules for a minerals processing facility (lithium)
- Design, fabrication, assembly and testing of two 132kV Electrical E-Houses located on Barrow Island in the northwest of Western Australia (oil and gas)
- Design, construction and installation of a Gold Room fume extraction system located in Kalgoorlie, Western Australia (gold)
- Design, construction and installation of an Electrical Bulk Liquid Berth Substation (Port Facility)
- Design and construction of a Compressor Station Switchroom located in the northern gold fields (oil and gas)
- Design, construction and installation of a Battery Energy Storage System located in Northern Queensland (alumina)

In addition to the above projects, Aerison has secured a new 3-year shutdown maintenance support services agreement for an iron ore producer.

Aerison Group Managing Director and CEO, Giuseppe Leone commented: "These new contracts expand our existing customer base and significantly increase our revenue forecast for FY22 as we continue to demonstrate the Company's solid track record of delivering for our customers. As the Company continues to grow, we look forward to building our valued long term customer relationships into 2023 and will actively target new customers by providing a quality turnkey service."
