Revenue Opportunities

The Platform has been designed to facilitate the generation of significant new revenue opportunities, including licensing, subscription, exclusive streaming and royalties, affiliate gaming revenue with potential customers that operate gaming communities and betting companies, esports and sporting news websites and esports tournament organisers.

Development team

To facilitate the development of SportsHero's innovative and cutting-edge artificial intelligence technology, the Company has engaged artificial intelligence specialist Ai-Driven Pty Limited (Ai-Driven). Ai-Driven is a technology company with offices in Australia and Asia that provide artificial intelligence solutions to small and medium enterprises globally.

The development team is led by Ai-Driven Chief Technical Officer, Mr Henry Tian. Henry is an experienced software engineer who specialises in machine learning and artificial intelligence.

Henry previously held senior development roles with one of the world's largest telco and smartphone manufacturers and is one of the top minds with respect to deep learning applications in Australia. Henry has authored multiple publications in journals worldwide, including articles in the prestigious European Journal of Electrical Engineering & Computer Science.

Agreement with Ai-Driven

Ai-Driven has agreed to take a percentage of their fees in the form of options. SportsHero will grant 3,000,000 options with exercise prices that significantly exceed the Company's current share price. The 3,000,000 options will be issued following completion, on the terms set below:

- (i) 1,000,000 options each exercisable at \$0.05 and expiring 31 October 2023;
- (ii) 1,000,000 options each exercisable at \$0.10 and expiring 30 November 2023; and
- (iii) 1,000,000 options each exercisable at \$0.20 and expiring 31 December 2023.
