### CAPITAL RAISE COMPLETED

Norwood Systems Ltd (Norwood or the Company) (ASX: NOR) is pleased to announce that it has completed its Placement of Fully Paid Ordinary Shares to sophisticated investors (“**Placement Shares**”) as announced to ASX on 12 October 2021. Alto Capital Pty Ltd AFSL 279099 (“**Alto Capital**”) was Lead Manager to the Placement and closed the placement oversubscribed by \$23,000.

Norwood has allotted the Placement Shares of 19,000,000 which has raised a total of \$323,000 before costs at an issue price of \$ 0.017 per share.

The Placement Shares have been issued under the Company’s placement capacity under ASX Listing Rule 7.1.
