The Company is party to a binding JV option agreement with Azimut Exploration Inc. (TSXV: AZM), to earn-in up to 70% of the Wapatik Gold-Copper Project, located in James Bay area, a tier 1 mining jurisdiction of Quebec, Canada.

On 3 September 2021, the Company announced the proposed acquisition of 75% of Northern Lights Minerals Pty Limited which holds a substantial land package across the Upper Eastmain Greenstone belt in Quebec, Canada. Completion of the acquisition is subject to a number of conditions precedent which remaining outstanding as of the date of this report.
