

Results of Scheme Meeting and General Meeting

Firefly Resources Limited (**ASX: FFR; Firefly** or **the Company**) is pleased to announce that Firefly Shareholders have today voted in favour of the proposed merger of Firefly by way of scheme of arrangement under which Gascoyne Resources Limited (ASX: GCY) (**Gascoyne**) will acquire all of the issued shares in Firefly in consideration for the issue of 0.34 fully paid ordinary shares in Gascoyne of each Firefly share (**Scheme**).

Firefly Shareholders also voted in favour of the proposed demerger of certain copper-gold and lithium assets which will be transferred to a newly incorporated entity, Firetail Resources Limited (**Firetail**), by way of a capital reduction and in-specie distribution of 1 fully paid ordinary share in Firetail for approximately every 11.91 Firefly shares (**Demerger**).

Voting Results of Scheme Meeting

In accordance with ASX Listing Rule 3.13.2 and section 251AA of the Corporations Act 2001 (Cth), Firefly advises that the resolution to approve the Scheme (**Scheme Resolution**), as set out in the Notice of Scheme Meeting attached to the Supplementary Disclosure dated 15 October 2021, was passed by the requisite majorities of Firefly Shareholders at the meeting of Firefly Shareholders (**Scheme Meeting**) held earlier today pursuant to orders made on 15 October 2021 by the Supreme Court of Western Australia (**Court**).

In summary:

- 92.96% of Firefly Shareholders present and voting (in person or by proxy, attorney or corporate representative) at the Scheme Meeting voted in favour of the Scheme Resolution; and
- 99.64% of the total number of votes cast by Firefly Shareholders were in favour of the Scheme Resolution.

Voting was conducted by a poll. The voting results in respect of the Scheme Resolution are attached to this announcement.

Second Court Hearing

The Scheme remains subject to a number of conditions, including the approval of the Court at the Second Court Hearing, currently scheduled to be heard at 2.00PM (Perth time) on 1 November 2021.

Voting Results of Demerger Meeting

In accordance with ASX Listing Rule 3.13.2 and section 251AA of the Corporations Act 2001 (Cth), Firefly provides the details of the resolutions and proxies received for the General Meeting held earlier today (**Demerger Meeting**). All resolutions were passed and decided by way of a poll.
