Under a funding agreement RiverFort Global Capital Ltd, a London based UK Institutional Investment Manager focusing on high-growth companies, has advanced the Company \$3.5 million which will be repaid from the proceeds of deep in the money Options, with the Options due to be exercised on or before 30 June 2022. Under the Funding Agreement Riverfort will be paid interest at a rate of 6% per annum, payable monthly, on the outstanding balance of the \$3.5 million. An amount of \$1.38 million was repaid during the quarter from options exercised.
