Highlights

SCEE Electrical awarded resources and infrastructure contracts totalling circa \$20m

Southern Cross Electrical Engineering Limited ("SCEE Group") is pleased to announce that its SCEE Electrical business has been awarded a range of contracts in the resources and infrastructure sector totaling circa \$20m as follows:

- In the Pilbara Western Australia, SCEE Electrical has been awarded by Hamersley Iron Pty Ltd (a Rio Tinto company) a contract for the supply of civil, structural, and electrical works for the installation of the balance of plant for the Tom Price 45MW/12MWh Battery Energy Storage for Spinning Reserve ("BESSR") Facility. The integration of this battery energy storage system into the network operator's existing power network has the goal of decarbonising the power generation portfolio and saving fuel costs. SCEE Electrical's works will commence immediately and are scheduled to be complete in July 2022.
- Also in Western Australia, Southern Ports Authority has awarded to SCEE Electrical at the Esperance Port Power Connection Project works to upgrade the power supply in preparation for upcoming upgrades at the port. The works are commencing now and are due to finish in February 2022.
- In Queensland, China Petroleum Engineering & Construction (Australia) Pty Ltd & Nacap Australia Pty Ltd ("the CPECC Nacap Joint Venture") has awarded a package of works on the well pad infrastructure in the Surat gas fields located near Dalby to SCEE Electrical under the Arrow Energy Off Plot Master Services Agreement (Surat). The works involve the supply, installation and inspection of hazardous area equipment and accessories enabling the various interfaces between the well heads, well head skids, control panels and generators. Works are scheduled to commence in late 2021 and due for completion in the second quarter of 2022.

Comment

Commenting on the award, SCEE Group Managing Director Graeme Dunn said "As the global energy sector transitions into cleaner fossil fuels and on into renewable energy sources and storage the SCEE Group is well positioned to support this conversion to take place.

I am particularly pleased to announce this battery project for Rio Tinto in the Pilbara following on from our NECA WA award-winning efforts at the Agnew Hybrid Renewable project. The SCEE Group is leveraged across many aspects of the lithium cycle including working at lithium mines, at lithium processing plants, manufacturing electric vehicle charging systems and installing the batteries themselves. In turn, this is only a subset of the many decarbonisation initiatives which the SCEE Group enables."
