ISSUE OF QUOTED OPTIONS AND CLEANSING NOTICE

Arizona Lithium Limited (ASX: AZL, AZLO) ("Arizona Lithium" or the "Company") has issued 86,666,709 quoted options as part of a placement to professional and sophisticated investors as set out in the Company's announcement of 1 November 2021 and as noted in the Company's Appendix 2A of 10 November 2021 ("Options").

The Options are exercisable at \$0.12 each and expire on 10 November 2022. The Options are trading under the ASX ticker AZLO.
