Corazon Mining Limited (ACN 112 898 825) (**Company**) is pleased to announce the issue of 31,250,000 fully paid ordinary shares in the Company (**Shares**) at an issue price of \$0.032 per Share as Tranche 2 in the placement announced by the Company on 15 September 2021 (**Placement**).
