JobKeeper Payments Notification

archTIS Limited (ASX:AR9, OTCQB:ARHLF) (archTIS or the Company) provides the attached notice relating to disclosure of JobKeeper payments in accordance with s323DB(1) of the Corporations Act 2001 (Cth).

During FY20 and FY21, archTIS and its subsidiaries received \$14,400 in JobKeeper payments (as disclosed in the Company's Annual Report for the financial year ended 30 June 2021). These payments were made to the Company's subsidiary, Nucleus Cyber Pty Ltd (**Nucleus Cyber**).

archTIS acquired Nucleus Cyber on 23 December 2020. Prior to the merger, Nucleus Cyber received an additional \$97,200 in JobKeeper payments. This has not been included in the disclosure below (nor in the financial statements of the Company), on the basis that Nucleus Cyber was not part of the consolidated reporting entity until 23 December 2020.
