

Nextmedicall Update

Advanced Human Imaging Limited (ASX: AHI) (AHI or the Company) is pleased to provide an update regarding the Binding Term Sheet executed with Nextmedicall S.A.C (**Nextmedicall**), a Peruvian technology company, to integrate the AHI CompleteScan Face and Body Scan capabilities into the Nextmedicall application, as announced on the ASX Platform on December 13, 2021.

Further clarity concerning the terms of the Binding Term Sheet are summarised below.

Summary of Material Terms:

Current Pilot	<p>Under the terms of the Binding Term Sheet, Nextmedicall have requested sufficient time to conclude the Entel Pilot prior to commencing integration.</p> <p>Normally, AHI's business partners are granted 14 days to conclude a Pilot program, however this has been increased to 30 days to account for potential delays over the holiday season (December 2021 and January 2022).</p> <p>*Entel is not party to this agreement and the pilot is not an indication of any potential commercial outcome.</p>
Formal Agreements to be Concluded	<p>The main commercial agreement (Commercial Agreement) between the parties pursuant to which AHI agrees to grant Nextmedicall the right to use AHI's licensed Software Development Kits (SDKs) and related intellectual property to integrate them into the Nextmedicall platforms/technology, incorporates the following:</p> <ul style="list-style-type: none">• Master Services Agreement,• The Software Development Kit, End User License Agreement,• Support Agreement,• Data Processing Agreement. <p>Under the terms of the Binding Term Sheet, the parties have agreed to conclude all the definitive agreements by no later than 120 days from the execution of the Binding Term Sheet. Should the formal agreements not be signed within this period, the Binding Term Sheet is annulled.</p>
Commercial Agreement (Additional Clauses)	The Commercial Agreement will incorporate standard representations and warranties, AHI's right to terminate and minimum user targets.
Integration	Nextmedicall have undertaken to complete the integration of the AHI MultiScan SDK within 120 days from the signing of the Binding Term Sheet, being Q2 2022. The integration will be undertaken by Nextmedicall and their development team. Therefore, AHI cannot guarantee that the integration timeframe will be met.

User Target	Under the terms of the Binding Term Sheet, Nextmedicall will target 20,000 active users per month on the Nextmedicall platform, within 12 months of the Nextmedicall application being launched. Note: this is a target, not a minimum amount.
Pricing	Pricing is based on AHI's standard price list (annexed) and is subject to volume and use case, and is expected to be finalised as part of the conclusion of the Commercial Agreement.
Financial Impact	AHI does not expect any financial return as a result of entering into this Binding Term Sheet. Financial return will be more readily identifiable upon the release of the application via the Nextmedicall platform.

- NB 2: above revenues are either per month, per user tier based pricing or individual scan-based pricing to be paid to AHI or as mutually agreed under arrangement between the parties.
- Monthly Face scan subscription is based on a monthly use policy, allowing the user to take up to 4 Face scans per month.
- Dermatological scans are not included in the per month, per user pricing.
- All above per month, per user pricing is based on a 12-month subscription.
