
CLEANSING NOTICE - s708A(5)(e) of the Corporations Act 2001

Battery Minerals Limited (ASX: BAT) (“**Battery Minerals**” or the “**Company**”) is pleased to confirm that it has issued 243,995,372 fully paid ordinary shares at \$0.011 per Share on 24 December 2021 pursuant to a placement to sophisticated, professional and institutional investors (the **Shares**), made up of 243,995,372 fully paid ordinary shares from the Company’s Listing Rule 7.1 capacity (refer to the Company’s ASX announcement of 17 December 2021 for further details).
