Shareholders are furthermore also referred to the company's interim report issued on 31 August 2021.

Management can confirm that there has been no revaluation of the A4 Royalty since the financial year ended 31 December 2020 in the determination of the NTA value. The A4 Royalty is currently being revalued internally and the effects thereof will be included in the Appendix 4E for the financial year ended 31 December 2021, which will be released to the market no later than the 28th of February 2022, from which time it will be included in the NTA.
