Titan Minerals Limited (ASX: TTM) ("Titan" or the "Company") is pleased to announce the appointment of experienced geologist Mr. Pablo Morelli as Exploration Manager for Titan Minerals. Pablo will oversee the exploration strategy across Titan's portfolio and expand upon the substantial discoveries and anomalies within the tenure. The strategy is to expand the Dynasty resource as well as explore the underlying porphyry potential of the project and unlock the epithermal and porphyry potential at the Linderos and Copper Duke projects.

Pablo has over 15 years' experience of working across various epithermal systems as well as copper-molybdenum, copper-gold and gold-rich style porphyry systems. This experience was gained working with Barrick, Newmont, Kinross and Rio Tinto working in Cretaceous, Palaeocene, Eocene-Oligocene and Miocene Belts of northern and central Chile, and Mexico.

Pablo recently worked as Geology and Exploration Superintendent on the Norte Abierto Project, a joint venture between Newmont & Barrick Gold, evaluating the Cerro Casale and Caspiche copper-gold projects. Norte Abierto reserves, and resources comprise of 23.2 Moz of gold and 5.8 Blbs of copper reserves, 26.6 Moz of gold and 6.7 Blbs of copper in the measured and indicated categories. Pablo was responsible for geological modelling and supervising the resource estimation of the Casale Project, working closely with the metallurgy and engineering department.

Pablo was Senior Geologist in the earlier stages of the project and managed technical operations. Pablo was responsible for the geological modelling of Caspiche and Casale projects; logging code implementation; geological logging and mapping mentoring, control and supervision; section interpretation and 3D modelling; and simultaneously managing the exploration team and a large number of drill rigs. Pablo also worked closely with highly regarded industry advisers for each specific study.
