8.8.1	Does the entity expect that it will continue to have the current level of net operating cash flows for the time being and, if not, why not?	
	Answer: As noted in the Quarterly Activities Report, the Company has been completing a substantial drilling program at its Detroit Project in Utah and has an additional 10 holes planned at its Drum gold mine to be completed shortly. The Company expects to have a lower level of net operating cash flows for the next quarter as the current program should complete in early February 2022. In any case, the Company will continue to review ongoing activities and has the ability to adjust expenditure according to available funding, if necessary.

Answer: *The Company will continue to monitor its available cash levels and can reduce its operating and exploration expenditure going forward, if needed. The Directors also have a strong track record of being able to raise funds when required.*

Answer: *Yes, the Company expects to continue its operations and exploration activities. These ongoing activities will be reviewed and adjusted according to available funding.*
