Drilling Update: Brooks and Thorsby Campaigns

Calima Energy Limited ("Calima" or the "Company") (ASX: CE1) is pleased to confirm that the Gemini #6 and #7 Sunburst horizontal wells at Brooks have both been drilled and the rig has been released. Leo #4 at North Thorsby has reached total depth.

Highlights:

- Pisces #2 & #1 (100%WI) have been tied into the 2-29 battery and both are on-stream on the 26th and 27th of January respectively with both wells seeing signs of oil in in the flowback fluid within hours of commencement
- Leo #4 Well (50% WI) was spud on 20 January 2022 and **reached total depth of 4,088m** measured depth (mMD) on 27 January
- Gemini #6 & #7 (100%WI), the 2nd and 3rd Sunburst wells of the 2022 drilling campaign, have both reached total depth and the rig was released 27 January 2022. The wells were drilled to measured depths of ~1,855 m, and 1,970 m and each well took 6 days to drill
- Capital program funded from operational cash flows and the Company's credit facility

2022 Drilling Campaign Summary

*vertical well

Jordan Kevol, CEO and President:

"The Company has finished drilling its 3-well Gemini Brooks Alberta program. This program consisted of a vertical stratigraphic test well targeting the Sunburst (Gemini #5) in a previously undrilled portion of our Sunburst fairway, plus two horizontal wells that were designed to extend the extent of known pools. The drill costs to date are on budget, and we are very pleased with the geological results of both the stratigraphic test, and the two horizontals. The rig has been released from Gemini #7, and this concludes the Brooks drilling for the quarter. We have started 2022 with a bang, having expedited our program by spudding two wells in December 2021, followed by 5 more in January 2022, the Company is well on its way to estimated production targets of 4,000 - 5,000 boe/d this half year. With the continued production increases being seen on Leo 1-3 combined with Pisces 1&2 now on production, we are pleased to be taking advantage of a growing production base in a rising energy super cycle"

Pisces Drilling Program update

Calima is pleased to report that both Pisces #1 & #2 have been fully equipped with production equipment, tied into the 2-29 battery, and have begun the initial flowback process. Pisces #2 came on







stream on January 26th, and within hours, started seeing signs of oil in the flowback fluid. Pisces #1 came on stream January 27th, and within hours, started seeing signs of oil in the flowback fluid.

Pisces #3 is currently awaiting availability of frac crews, and its subsequent testing and tie into the 2-29 battery at Bantry.

Leo #4 Well, 50% WI

Leo #4 is an unconventional oil well at North Thorsby and was spudded 20 January 2022. The well has reached total depth at 4,088 meters measured depth on 27 January. Rig release is anticipated in 3 days after the installation of the frac liner. The Company holds a 50% WI in the well and the North Thorsby prospect area, which is prospective for the development of multiple Sparky age oil bearing channel sands. The Company holds a significant land position in the North Thorsby area with its partner. No reserves are currently booked in the North Thorsby prospect area. No production facilities are currently owned at North Thorsby and will be added on an as-needed basis upon success subsequent to fracture completion and testing of Leo #4.

North Thorsby contains a series of 18-20° API oil charged Sparky Formation channel sands that contain some of the thickest oil columns in the regional area. North Thorsby is estimated to have over 200MMbbl OOIP with some of the sections approaching an OOIP of 28MMbbl. Active drilling to the east provides strong analogues and the Sparky intervals in North Thorsby are expected to be similar. With this resource scope, the area provides the potential for significant locations and reserves growth over time that will be strategically developed.

The well has been designed to test a thick channel for productivity and is the first step in starting to develop the Sparky and expand the greater Thorsby fairway. The well is a horizontal well that is designed with a cemented liner throughout the horizontal section with a series of multi-cycle frac ports within the portion of the wellbore that encountered the Sparky Formation. The Company plans to frac and tie-in the well in late Q2 or early Q3 2022, pending spring break-up conditions. Due to weather conditions and spring break up, timing for this work has not been finalized, however it will be planned to effectively minimize overall capital expenditures and risk of cost overruns.

The target Sparky intervals contain 10-30 meters of pay-zone with an average porosity of 13-15% and a corresponding average permeability of 5-15 millidarcies (mD). The Company currently has identified an inventory of 20-30 potential HZ locations with room to add additional locations with minor offset land purchases/leasing.

3 Well Gemini Oil and Gas Program

The **Gemini #6 & #7** horizontal wells targeted the Sunburst Formation in two known pools and were designed to extend the previously identified pool boundaries based on information from the Company's extensive 3D seismic database. The wells are classified as development wells, as they are adjacent to known pools, but are anticipated to capture reserves that would have been otherwise unrecovered by existing vertical wells completed in the same formation. Oil and gas shows while drilling was as expected.



Gemini #5, as previously released by the Company, successfully encountered prospective Sunburst age rock in an

area previously undrilled. The presence of this rock and its positive reservoir properties is consistent with 3D seismic interpretation. This vertical well has been cased, and is awaiting completion and subsequent production testing, that may validate future Sunburst horizontal drilling locations, that were previously un-booked in the Company's reserves.

Completion style and flowback

Both the vertical Gemini well and the two horizontal wells will have simple completion programs. The vertical requires only a perforation to allow hydrocarbons to enter the wellbore prior to the installation of artificial lift (pumping) equipment. The two horizontal Gemini wells are "open hole horizontals" where the high permeability, conventional rock is open to the wellbore, and only requires installation of pumping equipment prior to production testing operations. Once minimal amounts of "load fluid" are recovered, actual formation fluid will be pumped, and the inflow rates, and water cuts deliverable by the reservoir can be realized.

Tie-in operations

Once sufficient testing and fluid confirmation has occurred, the wells will be shut in and will await a pipeline project to be installed that will be used to connect the wells into our nearby Bantry oil processing facility at 2-29.
