2. In 2020 the Company implemented cost savings measures to help preserve our strong cash position. These savings and other cost reduction measures implemented have resulted in a substantial reduction in the cash payments from operating activities. Given these arrangements the Company does not have any short-term requirements for additional capital and remains confident that revenue generation and cash reserves will be sufficient under this operating expense regime to meet the cash funding expectations contained in our Prospectus dated 15 November 2019.
