PERFORMANCE RIGHT CONVERSION AND ISSUE OF SECURITIES

Future Metals NL ("**Future Metals**" or the "**Company**", **ASX|AIM: FME**), advises, in accordance with the terms of the Company's Performance Rights Plan and the issues of Performance Rights approved by shareholders at the Company's general meeting held on 4 June 2021, that 2,666,666 Class A Performance Rights and 2,666,667 Class B Performance Rights have been converted to fully paid ordinary shares. The shares issued on conversion will be escrowed until 22 June 2023.

Senior Management Performance Rights

As announced on 31 January 2022, the Company has finalised the issue of 4.9 million incentive Performance Rights with various vesting conditions to recently appointed senior managers and to the Company's Exploration Manager.

Corporate Adviser Options

Following the appointment of Barclay Wells Ltd to assist in the marketing of the Company and to introduce potential investors on a non-exclusive basis, the Company has issued the following options:

- i. 3,000,000 exercisable at A\$0.20 per share once the 20-day volume weighted average market share price ('VWAP') exceeds A\$0.30;
- ii. 3,000,000 exercisable at A\$0.20 per share once the 20-day VWAP exceeds A\$0.40; and
- iii. 3,000,000 exercisable at A\$0.20 per share once the 20-day VWAP exceeds A\$0.50.

All of these options have an expiry date of 22 June 2023.
