MONADELPHOUS CONTRACTS UPDATE

Engineering company Monadelphous Group Limited (ASX: MND) ("Monadelphous" or "the Company") today announced it has secured new contracts and contract extensions in the resources and energy sectors totalling approximately \$400 million.

The Company has been awarded a two-year extension to an existing contract with Woodside Energy Ltd to provide maintenance, shutdown and brownfields project services at the Woodside-operated onshore and offshore gas production facilities in the north-west of Western Australia (WA). The contract, which is valued at approximately \$150 million per annum (subject to the final work scope required each year), is an extension to the original five-year contract agreed in 2017.

In addition, Monadelphous has been awarded the following contract extensions:

- A 12-month extension for the supply of shutdown and major mechanical services at South 32's Worsley Alumina Refinery in Collie, WA, where the Company has been providing services since 2015; and
- A three-year extension for the operation and maintenance of Tronox's cogeneration power station in Kwinana, WA.

In Papua New Guinea, the Company has been awarded a contract with Newcrest to provide structural, mechanical, piping and electrical and instrumentation works on the Lihir Front End Recovery Project, with work expected to be completed in the first half of 2022.

In Chile, Monadelphous' maintenance and construction services business, Buildtek, has secured the following contracts at Codelco's operations in Calama:

- A three-year contract to provide mine infrastructure maintenance and repairs at the Chuqicamata underground copper mine; and
- A five-year contract to provide comprehensive maintenance of the heap leaching process and electrowinning copper extraction plant at the Radomiro Tomic copper mine. Buildtek has been providing services at Radomiro Tomic since 2012.

Buildtek has also been awarded its first contract with Collahuasi Mining Company, a company owned by Anglo American, Glencore and Japan Collahuasi Resources, to provide modifications to the concentrate distribution system at its Collahuasi Maritime Terminal in Punta Patache, south of Iquique in Chile. Work is expected to be completed in the first half of this year.

Monadelphous Managing Director Rob Velletri said the award of these contracts was a testament to the Company's proven track record of delivering value for its customers. "We are pleased to continue our long-standing relationships with these valued customers and are committed to continuing the provision of high quality, innovative and safe solutions," he said.
