**CLEANSING NOTICE UNDER SECTION 708A(5)(e) OF THE CORPORATIONS ACT**


As announced on 9 February 2022, W.A Kaolin Limited (Company) secured a \$12m funding package for Stage 1 ramp-up and Stage 2 acceleration at its Wickepin Kaolin Project located in Wickepin, Western Australia.

The Company completed a placement of 33,888,890 fully paid ordinary shares in the capital of the Company as part of the overall funding package to raise \$6.1m. The related Appendix 2A was also lodged today.

The Company gives notice pursuant to section 708A(5)(e) of the Corporations Act 2001 (Cth) (**Corporations Act**) that:
