















Andover - a fertile nickel & copper-rich environment



Southern Mineralised Corridor




- All Ni-Cu sulphide mineralisation hosted by a very distinctive intrusive rock type (taxitic gabbro)
- Gossans representing weathered massive Ni-Cu sulphides at surface occur within outcropping taxitic gabbro
- Disseminated and blebby Ni-Cu-Fe sulphides occur at surface in taxitic gabbro
- Drilling confirms Ni-Cu sulphides coincide with EM conductors in this corridor
- Coincident gossans and EM targets yet to be drilled



Andover Ni-Cu Sulphide Deposit



- Outcrops as a gossan & sulphides start at ~20m depth
- ~400m long x >550m deep
- Internal high-grade zones of massive sulphide:
 - > 4m 8m wide @ 2.0% Ni to 3.0% Ni
- Overall mineralised envelope:
 - > 15m 30m wide @ 1.0% Ni to 1.5% Ni
- Mineral Resource Estimate in Q1 2022




Ridgeline


- > 4.5m @ 3.95% Ni & 0.80% Cu






