# **Cokal BBM Project Progress at Batu Tuhup Jetty**

## **Key Highlights**

- Operations licence obtained for Batu Tuhup jetty;
- Soil Investigation Test Boring complete;
- 8 holes drilled for both land and jetty areas;
- Samples are in the laboratory being tested;
- Jetty engineering contracts awarded;
- Engineering and Civil Works design being finalised by external consultants.

Cokal Limited (ASX:CKA, "Cokal" or the "Company") already announced it has secured the site for its long term jetty at Batu Tuhup. The company has now started to develop the site.

To this end, a fleet of equipment to undertake earthworks is due to arrive on site on 10 March. Cokal will issue Infrastructure development works tenders as soon as the final plans have been agreed by BBM.
