Frontier Energy Limited (ASX: FHE) – Formerly Superior Lake Resources Limited (SUP) – Anticipated Reinstatement to Quotation

Description

It is anticipated that the securities of Frontier Energy Limited ('FHE') will be reinstated to quotation at the commencement of trading at 10:02:15 am AEDT on 3 March 2022, following its re-compliance with Chapters 1 and 2 of the ASX Listing Rules.

FHE raised \$8,000,000 pursuant to the offer under its prospectus dated 12 January 2022 as varied by the supplementary prospectus dated 16 February 2022 by the issue of 61,538,462 shares at an issue price of \$0.13 per share.
