Shares issued under Share Issue Notice under section 708A(5)(e) of the Corporations Act 2001

This notice is given by Core Lithium Ltd (ABN 80 146 287 809) (the **Company**) under section 708A(5)(e) of the Corporations Act 2001 (**Corporations Act**).

The Company has issued 8,142,181 fully paid ordinary shares (**Shares**) at an issue price of A\$0.45 per Share to investors that have exercised unquoted options and 750,000 Shares for nil consideration to employees that have exercised performance rights (**Share Issue**).
