



Notice under Section 708A of The Corporations Act 2001 (Cth) (Act)

Further to the announcement on 4 March 2022, Ausgold Limited ("Ausgold") gives notice of the following under section 708A (5)(e) of the Act:

1. Ausgold issued 274,750,380 fully paid ordinary shares (**Shares**), at an issue price of \$0.04 per share to sophisticated investors on 14 March 2022;
