#### **Trading Halt**

In accordance with ASX Listing Rule 17.1, Piedmont Lithium Inc. (ASX: PLL) ("Company") requests that the securities of the Company be placed in a trading halt with immediate effect. The Company advises that:

- The trading halt is requested in connection with a proposed capital raising to be undertaken by way of a U.S. public offering of the Company's shares ("Offering"). The trading halt is required to enable the Offering to be conducted in an orderly manner.
- 2. The Company requests that the trading halt remain in place until the earlier of such time as it makes an announcement to the market in relation to the outcome of the Offering or the commencement of trading on Thursday, March 24, 2022.
