**Pursuit Minerals Limited** (ASX: PUR) is pleased to announce that, with the Company's increasing focus on exploration activities, Mr Bob Affleck will assume the role of full time Managing Director, effective 1 April 2022 with Mr Freeman continuing to drive the corporate side of the business as Finance Director.
