Request for Trading Halt - Norwest Energy NL

In accordance with Listing Rule 17.1, Norwest Energy NL (**Norwest**) requests a trading halt for its ordinary shares (ASX Code: NWE) prior to the commencement of trading on Monday 4th April 2022.

Norwest provides the following information for the purposes of Listing Rule 17.1:

- the trading halt is requested pending an announcement by Norwest in relation to a capital raising;
- 2) Norwest requests the trading halt to remain in place until the earlier of:
 - a) The release of an announcement to the market in relation to the outcome of the capital raising; or
 - b) the commencement of trading on 6th April 2022.
- 3) Norwest expects that the trading halt will be ended by the announcement referred to in paragraph (1).
- 4) Norwest is not aware of any reason why the trading halt should not be granted, nor of any other information necessary to inform the market about the trading halt.
