The Company is currently in the process of undertaking due diligence on an Australian based seafood wholesale exporter (Target) in respect of a potential acquisition transaction. While the due diligence is being undertaken with the co-operation of the Target, there is no executed agreement in respect of the transaction and negotiations between the parties remain incomplete. The Company will update the market upon any binding acquisition agreement being executed.
