Recommended and Unconditional Takeover Offer for Bullseye Takeovers Panel Application

Emerald Resources NL (ASX: EMR) ("Emerald") refers to its previous announcements in relation to its recommended and unconditional takeover bid for all of the issued shares of Bullseye Mining Limited (Bullseye) that it does not already own (Offer).

On 22 April 2022, the Takeovers Panel issued a media release regarding an application received from Au Xingao Investment Pty Ltd (Au Xingao) in relation to the affairs of Bullseye. The media release contains the summary details of application which include (amongst other things) the failure by Bullseye to register at least 10 share transfers by Bullseye shareholders.

Emerald notes that no decision has been made by the Panel whether to conduct proceedings. Au Xingao seeks an interim order to restrain Emerald from processing acceptances under its Offer in relation to any of the shares the subject of the alleged unregistered transfers. Emerald wishes to clarify that this proposed interim order only relates to a total 213,260 Bullseye shares.

Emerald confirms that it is not otherwise prohibited from processing acceptances under its Offer.

Bullseye shareholders encouraged to accept the Offer

Emerald urges all Bullseye shareholders who have not yet accepted the Offer made to them to ACCEPT WITHOUT DELAY before the Offer closes and become an Emerald shareholder. Emerald consideration shares will be issued within 2 business days for those that provide their written confirmation of their acceptance and for those Bullseye shareholders that do not withdraw or do not opt to waive their withdrawal rights, Emerald consideration shares will be issued within 5 business days of completion of the withdrawal right period on 29 April 2022.
